Application for a Temporary Resident Visa - Checklist

In addition to the documents requested on the <u>Document Checklist For a Temporary</u> <u>Resident Visa (IMM 5484)</u> you must *also* provide the following documents, if applicable.

All documents must be submitted at the same time as your application and processing fee.

Any document not in English or French must be accompanied by a certified translation.

Failure to submit all required documentation may result in the refusal of your application or processing delays.

False statements or submission of fraudulent documents will result in immediate refusal.

You must submit :	√
Valid passport or travel document	
Each person travelling, including children must have their own passport.	
 Passports must have at least one blank page and be valid for at least one month from the date you plan to leave Canada. 	
NOTE: If the processing time for your category exceeds 2 weeks, submitting your original passport with your application is optional. Please keep in mind that processing may be faster if we already have your passport when the decision is made.	
If you are a resident of Pakistan or Afghanistan submitting your application through visa application centres in Islamabad, Lahore or Karachi, please submit a copy of your current and previous passports including the biographic information page, and all pages that are not blank. A copy of the original passport is needed for each application even if you are submitting your original passport.	
Gulf residence visa	_
If your most recent Gulf residence visa is not affixed on your valid passport, please provide a copy.	
Proof of funds	
CAN+ If you have travelled to Canada in the last ten (10) years or currently hold a valid United States nonimmigrant visa and can provide proof (entry stamps in passport, proof of the valid visa), no proof of financial support is needed.	_
For all others, provide proof of financial support to cover the expenses for the duration of your visit:	
Copies of bank statements or bank book covering the past three months.	
 Any additional relevant documentation (employment letter, pay slips, proof of pension, business registration, investments, etc.) 	

If you are not paying for your own trip: Provide a letter signed by the person paying and a photocopy of their passport, or other official identification with photo and a bank certificate proving that they have sufficient funds. Describe how this person is related to you. These documents must be dated within three months of the date on which the application is submitted. If you are travelling on business: Letters from your employer and the host company in Canada outlining the purpose of your visit. Letter should indicate who is bearing all travel costs. If you are a self-employed person or a business owner: Copies of your company's trade license indicating the expiry date and the number of shareholders in the company. This document must always be accompanied by an English or French translation. Copies of your personal bank statements for the past three months. For all cases: Any other relevant documentation you wish to submit in support of your application. Information about your proposed stay in Canada: Invitation letter and any documents related to your host in Canada. Proposed flight itinerary, if any. Hotel reservations, if any. Proof of travel insurance, if any. Registrations for events or programs you are planning to attend. **Proof of current studies** – an official document confirming your registration as a student at an academic institution. Minors travelling alone or with only one parent - you must provide proof of custody or a consent letter from your non-accompanying parent. You must send a consent letter with a copy of the non-accompanying parent's civil identity document with signature (e.g. biographical passport with the signed signature page). If you have answered "yes" to any of the background information questions on the application form, provide a completed and signed **Schedule 1** form (Application for Temporary Resident Visa – IMM 5257B) and include it with your application. Family Information Form IMM 5707, fully completed, dated and signed.
