#### PORT OF SPAIN VISA OFFICE INSTRUCTIONS – WORK PERMIT

- This document checklist is one of several documents that you need to submit with your application.
- Any documents not in English or French must be accompanied by a certified translation.
- A visa officer will make a decision based on the documents you submit. Additional documents will
  not be requested. Failure to submit relevant documents may result in your application being
  returned, delayed or refused.
- False statements or submission of fraudulent documents will result in refusal of your application. In addition, you will become inadmissible from entering Canada for five (5) years.
- The submission of an application does not guarantee the issuance of a work permit/visa. Do not finalize travel plans until you have received a visa.
